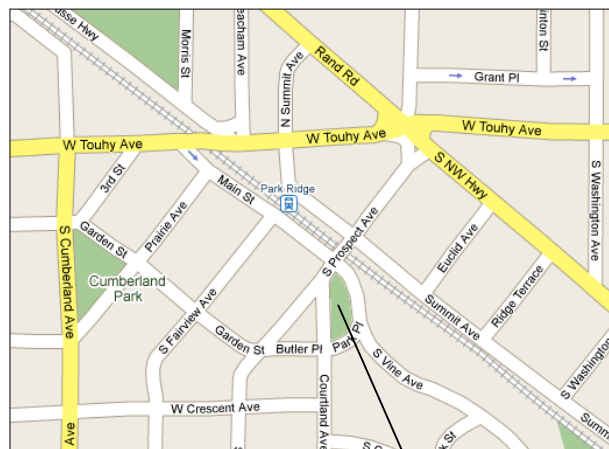

**Park Ridge Art League** sponsors a yearly Art Fair featuring fine art, and one of a kind functional art. The Art Fair offers *Awards of Excellence*, *Awards of Merit*, each in 2- and 3-D, and *Purchase Awards*. Purchase Awards are either from companies, businesses, or private collectors.

The League hosts an average of 60 artists in a variety of media. Over the two days of the show, artists can anticipate greeting about 3000 visitors.

The Art Fair is held at Hodges Park in downtown Park Ridge, directly in front of City Hall at the intersection of Prospect, Courtland, and Vine Aves (one block south of the Pickwick Theater). It is directly south of the railroad tracks on Prospect Avenue. The park is a well-used cultural center of the city hosting the art fair and weekly summer concerts.

### Show Details

**Registration and Set-up:** Friday night set-up after 6 p.m. or on Saturday from 6 a.m. – 10 a.m. Additional details and booth assignment will be provided with acceptance letter. Note: There is NO overnight security.

**Media:** This juried show is open to fine art and one of a kind utilitarian art. All work must be original and created by the artist.

**Exhibitor spaces:** 10x10, usually with additional space for your supplies behind the tent. Staking is not permitted.

**Jurying:** The show is juried for first time exhibitors. This jury application is due by May 1. However, jurying is an ongoing process and you will receive acceptance notification upon prompt review of your work.

Enclose 3 photos of your work on slides, photographs, or a CD. We can also view and judge your work from your website. Include your name and media on your jury items. Items submitted for jurying are not returned.

**Fees:** \$15 non-refundable jury fee is due with this form. If your work is accepted, you will receive prompt written confirmation and an invoice for \$80 (\$25 membership + \$55 booth).

**Note:** The Art Fair is a members-only show and your membership is included in the \$80 fee. The membership year starts July 1 and ends June 30; therefore, your membership would end June 30, 2012, just after the art fair. We hope that you would renew your membership for the following year.

- The \$15 jury application is due by May 1. You will receive acceptance notification upon prompt review of your work.
- Make a check for \$15 payable to **Park Ridge Art League**.
- Include jury media.
- Include a self-addressed, stamped #10 business envelope for acceptance/instruction information.
